



2025 AORR Strategy

„Strong, Active and Responsible AORR”

- **Organizational consolidation of AORR through the establishment of subsidiaries and branches on the territory of Romania and the numerical and qualitative increase of its capacity of action, according to the statutory objectives and goals.**
 - setting up branches and subsidiaries in the main cities and municipalities where military personnel in reserve and retired, as well as volunteer reservists live.
 - establishing functional departments in AORR at national level: organizational; staff; legal; cooperation with the Romanian Parliament and central structures of the MoD; professional and scientific; culture and sports; support of volunteer reservists; collaboration with other reserve military personnel's associative structures, as well as with those of reservists from the National Security System and with Civil society; cooperation with CIOR and other European similar structures; communication and press etc.
 - planning and developing AORR activity based on medium and long term projects.
 - activation and attraction of honorary members and associates of the AORR, the Non-Commissioned Officers in reserve, volunteer reservists for the main activities of the Association, at national and local levels.
 - economic and financial consolidation of AORR, efficient use of funds from contributions, sponsorships, donations, tax quotas, access to European funds, etc.



- affirming the AORR as a credible force for representing all interests of the military personnel in reserve, in retirement and of the volunteer reservists.
 - supporting an efficient communication system to promote the interests of the Association, according to the specific Strategy.
 - obtaining the status of public utility.

- **Asserting the scientific and creative professional potential of the AORR leadership and members by participating in the modernization of the national and collective defense processes, of equipping with modern combat means, the realization of the unity of action with the active personnel of the Romanian Armed Forces.**
 - organizing an annual Symposium with the following theme: *“The Reserve, a component of the national increased military power.”*
 - the active involvement of AORR in the process of modernizing the national defense legislative framework.
 - achieving the Partnership Agreement with the leadership of the Ministry of Defense and the Defence Staff in order to systematic organise those activities aimed to fulfill interests of reservists and voluntary reserve.
 - active participation in promoting the patriotic spirit and the national interest in the Romanian society.
 - advising all institutions concerned on national defense issues, especially for the Reserve Forces.
 - systematically informing AORR members about the new NATO strategic concepts, the lessons learned from the participation of the Romanian military personnel in missions and operations led by NATO, the UN and the EU.
 - systematic participating of AORR representatives in important events and combat training activities organized by the MoD, CHOD, Single Services, Formations and Units



- HQs: exercises, evaluations, Range firings days, Reservists' Days, Arms' Days, Romanian Armed Forces' Day, National Anthem and the Flag's Days, Armaments Exhibitions, etc.
- systematic developing activities to achieve unity of action between Active and Reserve military, promoting the positive image of the Romanian Armed Forces and the military profession in the Civil society.
 - assuring the patronage of the National Military Colleges, Application Schools, in which the volunteer rescuers are trained and the Single Services' Academies.

- **Implementation of the unity of action of all Reserve military personnel associations and unions for defending interests of Officers, Non-Commissioned Officers and All Ranks, active, in reserve or retired and volunteers.**
 - elaborating the legal framework for establishing a confederation representing majority of military reserve personnel associations and unions, based on entrusted mandates of each structure, common interests in relation to the structures of power and state administration. The confederation will be organised on a rotational basis for its Presidency with presidents of component associations.
 - continuing the Forum activity of the associative structures of the military reserve and retired personnel to establish common objectives and concrete action strategies for defending interests of reservists, the system of the military service pensions and the financial rights of the voluntary reservists.
 - establishing a permanent working system for consulting reservists, knowing in their issues in details, supporting them in the relations with the decision-making institutions and systematically informing them about the results of the actions taken.



- promoting, as a priority, the dialogue with the decision-making structures of the Romanian state institutions, the active contribution to the elaboration of the decisions regarding the social and health problems of reservists and the diversification of the modalities of action according to the reactions of the respective state institutions.
 - solving social issues of reservists, finding solutions to protect those in suffering, loneliness, or without support. Attracting military reserve doctors in designing and implementing specific measures.
 - actively involving in the social life of Civil communities in which AORR members belong.

- **Active participation of AORR in CIOR activities, systematic organization of its activities in Romania.**
 - systematically collaboration of the AORR Executive Council (CD) with the CIOR Presidential Team, ensuring participation in the main activities of this organization and supporting initiatives in the interest of Romania.
 - participating in the rotational positions of CIOR Presidential Team, creating the legal framework for attracting the active MoD support to establish adequate conditions for hosting CIOR activities and participating in the management of the international Confederation and the financial support of their activities.
 - participating of military athletes and teams representing Romanian reservists in military competitions held under the aegis of CIOR.
 - systematically conducting joint activities with Republic of Moldova reservist associations and establishing conditions for their accession to CIOR.
